# Annual Report 2020 - 2021

Income in FY 2021:  
**\$1,381,000**  
*(up 4% over FY 2020)*

- **3,064** Individual donors
- **\$96,000** for grants to 73 teachers for the 2021-2022 school year, impacting **35,000** students
- **\$300,000** donated to FCPS IT services to support virtual learning during the pandemic
- **\$200,000** raised to provide school supply kits to students in need
- **\$75,000** to support the FCPS Honors event and employee recognition programs
- **\$20,000** to provide FCPS students experiencing homelessness with emergency needs
- **Areas of Focus:** Kids in Need, Innovative Teacher Grants, Employee Recognition
